I. COMPANY PROFILE

Steel Authority of India Limited (SAIL) was incorporated under the Indian Companies Act, 1956 with the objective to plan, promote and organize an integrated and efficient development of iron and steel and associated input industries. "The Public Sector Iron and Steel Companies (Restructuring and Miscellaneous Provisions) Act, 1978" was enacted with the aim to bring all the public sector integrated plants under the overall control of an integrated company i.e. SAIL which is to function as an integral steel complex. SAIL is a Schedule 'A' / Maharatna PSE in Steel sector with the administrative jurisdiction of Ministry of Steel.

The company employed 56254 regular employees (Executives 10323 & Non-Executives 45931) as on 31.3.2024.

The authorized and paid up capital of the Company was Rs. 5000 crores and Rs. 4130.53 crores respectively as on 31.03.2024.

Its Registered and Corporate offices are at New Delhi.

The shareholding of the Government of India in the company is 65% as on 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director-in-charge of Bokaro Steel Plant is a member of the Board of Directors and reports to Chairman. He/she is the overall in-charge of Bokaro Steel Plant and is responsible for efficient functioning of the Plant and the concerned mines for achieving the corporate objectives and

performance parameters. He/she will also be responsible for project implementation at the plant/concerned mines and for marketing/ sales of products from the Plant/ concerned mines.

III. ELIGIBILITY

3. QUALIFICATION:

The applicant should be an engineering graduate with good academic record from a recognized University/ Institution.

Applicants with MBA/ PGDM will have an added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical and operational experience at a senior level of management in a large organization of repute, out of which at least five years during the last ten years should have been in Steel Sector.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
