2. Normally, for appointment to the Board level positions, vigilance profile from CVO are required at the time of forwarding application, selection meeting and finally at the time of sending proposals to CVC with regard to appointment of recommended candidate. In view of the directives from PESB, the concerned Nodal Officer and vigilance functionaries may also be suitably directed to ensure that the vigilance profile of the candidates, as and when called for during the selection process by Ministry / PESB, are complete in all respect covering last 10 years' service period of the official concerned.

Your kind attention is invited to the selection meetings held by Public Enterprises Selection Board (PESB) for Board level posts in various Public Sector Undertakings. During such meetings, the PESB, inter-alia, peruses the vigilance profile of the shortlisted candidates for the last 10 years. For furnishing requisite information to PESB, Ministries/ Departments/ PSUs have already nominated Nodal Officers. However, in recent past, it has been observed that in certain cases the Nodal Officers are sending vigilance profile of the candidates selected for the interview only for the period the candidate is working under their Ministry/Department/PSU, which sometimes does not cover the mandatory period of 10 years, as required in the format prescribed by CVC. The lack of vigilance profile for 10 years not only causes inconvenience to the PESB but may also render a candidate to become ineligible from attending the interview during the selection meeting.

2. I would, therefore, request you to direct the Nodal Officer of your Ministry/Department/PSU to ensure that vigilance profile of the candidate for the 10 years in the prescribed format duly signed by HoD or the CVO is furnished two days before the selection meeting. The vigilance profile may also be uploaded on the PESB's website. This may avoid any possibility of disallowing such candidate from attending the interview by Board.
