ANNEXURE-II

Terms and Conditions of the Contract

Under the service contract the firm /company will undertake to inspect service and maintain the NEC Aspila Ex KTS System in the Office and Residence of Hon'ble Steel Minister, Ministry of Steel upto 31.03.2015. During the said period the Company's representative will carry out periodical inspection at least twice in a month.

During the validity of the contract, the company will render representative for maintenance services on the equipment at the frequency mentioned above. The equipment will be thoroughly cleaned, tested, repaired and kept in working condition.

- i) The Company will provide skilled engineer to attend the NEC Aspila Ex KTS System installed in the Office and Residence of Hon'ble Steel Minister, Ministry of Steel and when complaints are lodged.
- ii) After overhauling the NEC Aspila Ex KTS System installed in the Office and Residence of Hon'ble Steel Minister, Ministry of Steel guarantee for a period of one year shall be given so that there will be no need for its re-overhauling and adjustment in case any necessity arises within a year. This will have to be done free of cost.
- The Ministry of Steel reserves the right to foreclose the contract even before 31.03.2015 without prior notice if the performance of the company is not found satisfactory. In the even of failure of the company to fulfill any of its contractual obligations to the client will be entitled, without prejudice to its any other rights available to it, terminate the Contract and on such termination, the company shall be liable to refund forthwith but preferably within 15 days from the date of the letter of communicating the termination, the balance of the advance for the un-expired period along with the interest @ 18% per annum to be accrued from the date of drawal of such advance till the date of refund thereof.
- The Company will undertake to discharge all its obligations under the Contract in good workmanship manner and in case NEC Aspila Ex KTS System remains idle for want of repairs for more than 24 hours successive period the Company shall immediately refund the total charges for the corresponding period. In case NEC Aspila Ex KTS System is idle for replacement of parts the same may be fitted in reasonable time otherwise the company will be liable to refund the total maintenance charges for the corresponding period.
- v) The Company will produce a certificate that it is not providing the services for repair and replacement of the parts, components to other Ministries/ Departments at lower rates. If at any later stage, it is found that the company has quoted higher rates for this Ministry as compared to other Departments, all payments to company will be stopped and the Earnest Money will be forfeited.
