Visakhapatnam Steel Plant is the first shore-based Integrated Steel Plant in India. It is a producer of long steel products and caters to the requirements of the Construction, Infrastructure, Manufacturing & Automobile sectors.

RINL has one subsidiary company viz. Eastern Investment Limited (EIL) with 51% shareholding, which in turn has two subsidiaries, viz. M/s Orissa Mineral Development Company Ltd (OMDC) and M/s Bisra Stone Lime Company Ltd (BSLC).
