The quotations received in time will be opened at 03.30 P.M. **on the same day (14th May, 2010)**. The quotations should be dropped in the Tender Box kept at Reception of Gate No.1, Udyog Bhawan, New Delhi. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". **The vehicle will be available for inspection between 3.00 PM to 5.00 P.M. on 12th and 13th May, 2010.**

3. The quotations received in time will be opened in Room No.74, Udyog Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.

4. The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money of Rs.5000/- payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Steel, New Delhi.
- ii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favour of Pay and Accounts Officer, Ministry of Steel, New Delhi within two working days of the acceptance of the bid.

- iv) The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid.
