Terms and Conditions of the Contract

Under the service contract the firm/company will undertake to inspect, service and maintain the Siemens KTS installed in the Office of MOS, Residential Office of MOS and in the Ministry for a period of one year i.e. from 1.04.08 to 31.3.2009. During the said period the Company's representative will carry out periodically inspection at least twice in a month.

During the validity of the contract, the company will render representive maintenance services on the equipment at the frequency mentioned above. The equipment will be thoroughly cleaned, tested, repaired and kept in working condition.

- (ii) The company will provide skilled engineer to attend the Siemens KTS installed in the Office of MOS, Residential Office of MOS and in the Ministry and when complaints are lodged.
- (iii) After overhauling the Siemens KTS installed in the Office of MOS, Residential Office of MOS and in the Ministry guarantee for a period of one year (1.4.2008 to 31.3,2009) shall be given so that there will be no need for its re-overhauling and adjustment. In case any necessity arises within a year. This will have to be done free of cost.
- (iv) The Ministry of Steel reserves the right to foreclose the contract even before 31.3.2009 without prior notice if the performance of the company is not foind satisfactory. In the event of failure of the Company to fulfill any of its contractual obligations to the Client will be entitled, without prejudice to its any other rights available to it, terminate the Contract and on such termination, the Company shall be liable to refund forthwith but preferably within 15 days from the date of the letter of communicating the termination, the balance of the advance for the un-expired period alongwith the interest @ 18% per annum to be accrued from the date of drawal of such advance till the date of refund thereof.
- (v) The Company will undertake to discharge all its obligations under the Contract in good workmanship manner and in case C-Dot Exchange remains idle for want of repairs for more than 24 hours successive period the Company shall immediately refund the total charges for the corresponding period. In case C-Dot Exchange is idle for replacement of parts the same may be fitted in reasonable time otherwise the company will be liable to refund the total maintenance charges for the corresponding period.
- (vi) In witness whereof the Ministry of Steel and the Company through then respective authorized representatives causes this AMC executed on the day and year mentioned above.
