**SHORTAGE OF STEEL PRODUCTS**

1112. SHRI PARIMAL NATHWANI:  
SHRI SUBHAS CHANDRA BOSE PILLI:

Will the Minister of Steel be pleased to state:

- whether it has come to the notice of Government that housing and construction projects are staring at a slowdown for a few months with dealers and buyers reporting a shortage of long steel products, such as rods, bars and wires;
- if so, the details thereof;
- whether the shortage is due to lack of availability of iron ore; and
- if so, what measures Government plans to adopt to address the issue?

**ANSWER**

THE MINISTER OF STEEL

(a) The consumption and production of long steel products had substantially reduced during the period from April to June, 2020 following the Covid-19 pandemic. With the gradual unlocking measures undertaken by the government, the consumption and production of long steel products have since recovered and reached the previous year's level during the recent months.

(b) The production and consumption details of long products during April-December, 2020 and CPLY are given in the table below:-

(c)&(d): The production of iron ore was 112 MT during April-November, 2020 as compared to 152 MT during the corresponding period last year inter alia due to non-operationalization of 13 working mining leases in Odisha, post their auction in March 2020. Measures taken by the Government to increase availability of iron ore, inter-alia, include ramping up production of iron ore, grant of permission to SAIL to sell fresh fines and dumps and tailings, accelerating auction of iron-ore fines by SAIL and early operationalisation of forfeited working mines of Odisha etc.
